3. Each applicant may only apply to not more than two schools.
4. Please submit your application form along with the photocopies of the following documents to our school from **2024-01-02 to 2024-01-16**.
 - 4.1 Copies of Report Cards of Primary 5 & Primary 6 (First Exam)
 - 4.2 Extra-curricular Activities Records
 - 4.3 A self-addressed envelope with stamp
 - 4.4 **DO NOT** submit any recommendation letter of Primary School.
5. Application form and the required documents can be submitted to our school in person or by post.
 - 5.1 If the application form and the required documents are submitted **in person**, please submit to our school during the office hours.

Saturday: 09:00 to 12:00)
 - 5.2 If the application is submitted through the **EDB eSSPA platform**, the scanned copies of the **documents 4.1, 4.2 and the school application form** should be submitted through the eSSPA platform. Applicant should submit the **self-addressed envelope with stamp** to the school not later than **2024-02-06** within the office hours. For the details of the online application, please refer to the information from the primary school.
6. The successful applicants will be informed through mail and phone call on 2024-03-27. Please be reminded to write the 'Contact Telephone No.' clearly. Other applicants will not be told their status.
7. The official result of your application will only be announced by EDB through the Allocation System in July 2024. **DO NOT** call our school for the result.

9. Selecting Applicants:
